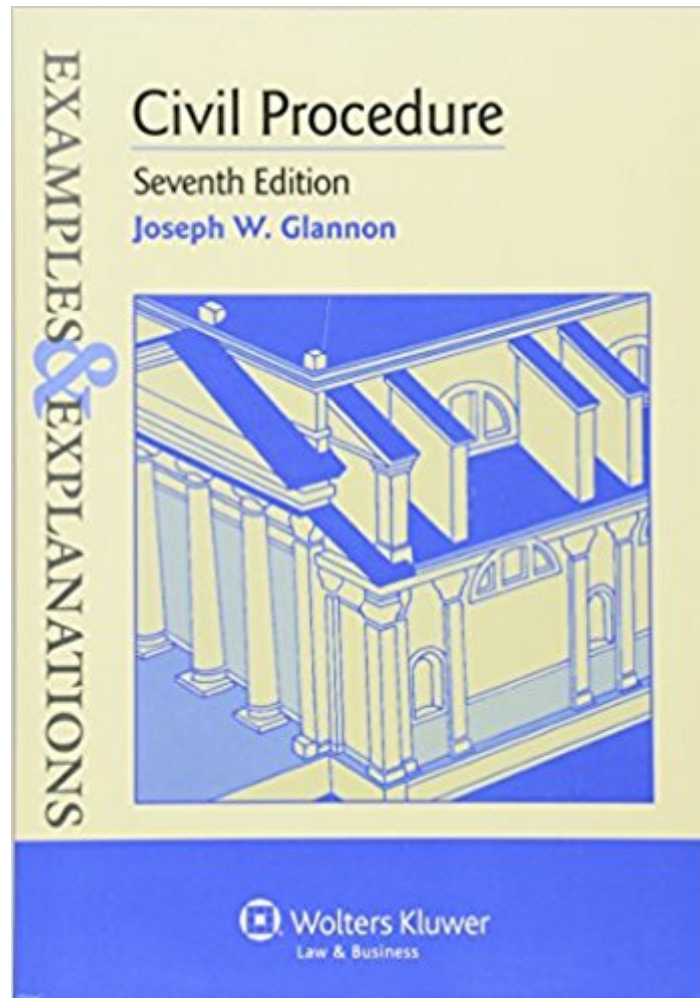

This book REALLY helped me study for/outline for my Civ Pro final. My professor glossed over some really important doctrinal points, and this book walks you step-by-step through just about everything Civil Procedure. HIGHLY RECOMMEND this for any first year law student.

I bought the whole set of E&Es for my first year classes but found them of marginal value. I did not find this as helpful as listening to the lectures and performing the reading. I guess if one could attend all lectures, perform all assigned reading, handle extra-curriculars and do the additional reading it might be worth it. But I found very few people have the time to do all that. I did not find this a good substitute for the doing the assigned readings and appearing in lectures, but it can be helpful if you come across a troubling case. I found the value marginal at best.

I just wish I would have started using it sooner. I bought it after midterms. Our professor, at least, tested strictly on the application of the procedure, not so much knowing what the procedure is. This guide helps do just that.

I had to teach myself Civil Procedure this semester, and the E&E was PERFECT for that. So easy to understand and built-in assessments to keep you on track.
