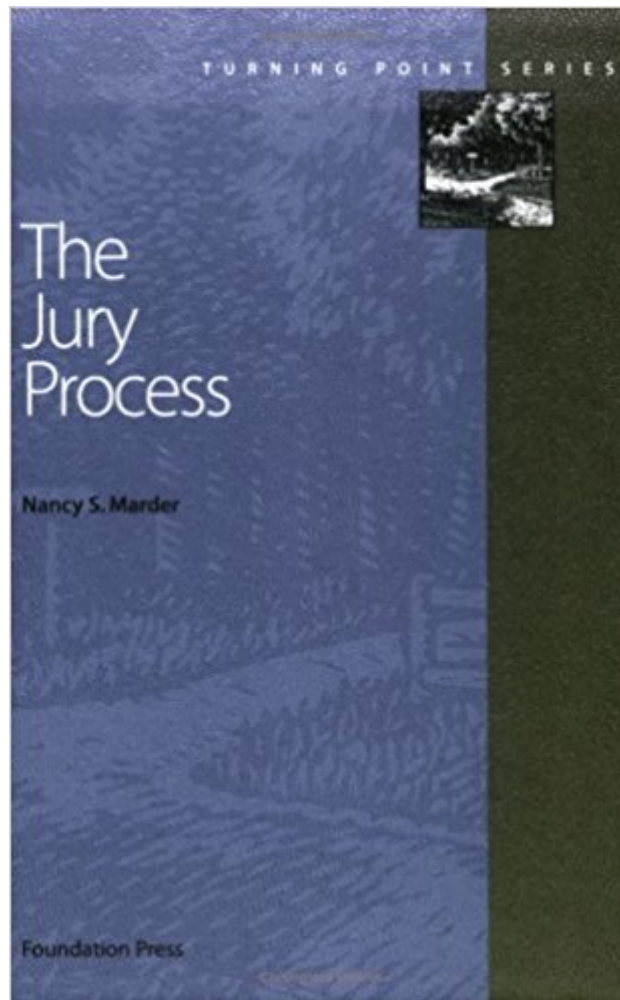

Civil Procedure: Jury Process provides a comprehensive examination of the jury, beginning with a brief look at its historical roles and ending with a consideration of the future of the jury as an institution. The book is organized around several of the key stages of the jury, from the venire, voir dire, and exercise of peremptory challenges to jury deliberations and post-verdict interviews of jurors.
